OVERVIEW

【Present Situation】

The Subject is a trading enterprise, which involved in the sales, storage and transportation of seamless steel tubes

The Subject is one of the largest companies dealing with the sales of seamless steel tubes. At present, its stock consists of over 5,000 different specifications of drill pipe, seamless steel tube, oil pipe, electric power tube pipe, high pressure boiler tube, steel pipe, fertilizer tube and fluid tube, etc.

The Subject not only deals with a range of tube and pipes being supplied by its affiliated enterprise, namely 江阴市XX钢管总厂 (translated as Jiangyin XX Steel Tube Main Factory), but also those being manufactured by Baosteel Group Corporation 宝钢集团有限公司, Baotou Iron & Steel (Group) Co., Ltd. 包头钢铁集团有限公司, Tianjin Pipe Corporation Limited 天津钢管有限责任公司, 成都无缝钢管有限责任公司 (translated as Chengdu Seamless Steel Tube Company Limited and Daye Special Steel Co., Ltd. 大冶特殊钢股份有限公司, etc. The Subject's products are both sold in China and overseas. The Subject's branches are responsible for the communications and sales of products in China. United States, Germany and countries in Southeast Asia are the countries where the Subject exports its products to.

The Subject's warehouse occupied approximately 108,000 sq. m., which consists of 32 sets of lifting equipment in various types and over 30 vehicles for transportation purposes. The Subject can provide storage and transportation services for its clients. The annual sales in 2009 exceed 800,000 tons with the sales reached RMB four billion.

The Subject's operation income in 2008 amounted to RMB 4,040,059,000.00, which increased by 21.79% as compared to the previous year. The total profit valued RMB 232,996,000.00 in 2008, which also experienced a growth of over 93 times as compared to previous year.
